### **ORDER**

Whereas, the Shri Jagannath Sanskrit Vishvavidyalaya, Plot No.- 1441-1469, Vill.- Puri, P.O.- Shri VIhar, Tehsil-Town- Puri, Dist.- Puri, Odisha- 752003 (Code No. ERCAPP1305) was granted recognition for conducting B.Ed. course of one year duration with an annual intake of 100 students vide ERC's order no. ERC/7-139.6.9/NCTE/B.Ed./2012/13259 dt 13.08.2012 from the academic session 2012-2013.

- 2. And whereas, a Revised Recognition Order (RRO) was issued to the institution vide order no. ERC/NCTE/ERCAPP1305/Shiksha Shastri- B.Ed.(Revised Order)/2015/32703 dt. 31.05.2015 for conducting Shiksha Shastri (B.Ed.) course of two years duration with an annual intake of 100 students for two basic units with 50 students each from the academic session 2015-2016 as per the NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- 3. And whereas, the ERC in its 278<sup>th</sup> meeting held on 16<sup>th</sup> 18<sup>th</sup> January, 2019 considered the matter and decided as follows:-

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and the following observation was made:-

(i) Two show cause notices issued on 20.04.2018 & 18.05.2019 and no reply has been received till date.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21."

Accordingly, recognition granted to the institution was withdrawn u/s 17(1) vide order no. F.No.ER-278.5/ERCAPP1305/B.Ed./2020/62159 dt. 28.01.2020 from the academic session 2020-2021.

- 4. And whereas, the institution preferred an appeal at the NCTE Hqrs. against the withdrawal order dt. 28.01.2020 and the Appellate Authority vide order no.89-88/E-157929/2020 Appeal/22<sup>nd</sup> Mtg.-2020/9<sup>th</sup> October, 2020/94489 dt. 19.10.2020 remanded back the case to the ERC for revisiting the matter.
- 5. And whereas, the ERC in its 286<sup>th</sup> meeting held on 25<sup>th</sup> & 26<sup>th</sup> November, 2020 considered the reply dt. 02.11.2020 submitted by the institution alongwith the appeal order dt. 19.10.2020, the original file & other related documents in light of the NCTE Act, 1993, NCTE Regulations, Guidelines issued by the NCTE from time to time and decided as under:-

"Restoration of recognition order for an annual intake of one unit (50 students) be issued."

Now therefore, recognition of the Shri Jagannath Sanskrit Vishvavidyalaya, Plot No.- 1441-1469, Vill.- Puri, P.O.- Shri VIhar, Tehsil-Town- Puri, Dist.- Puri, Odisha- 752003 (Code No. ERCAPP1305), withdrawn vide order dt. 28.08.2019, has been restored for conducting Shiksha Shastri (B.Ed.) course of two years duration with an annual intake of 50 students (one unit).
