**ADMISSION NOTICE**

Admission is open for one year Visistacharya (M.Phil) course in Sahitya, Vyakarana, Veda, Sarvadarshan, Dharmashastra, Nyaya, Advaita Vedanta & Jyotirvigyan in the P.G.Teaching Department of Shri Jagannath Sanskrit Vishva Vidyalaya, Puri for the year 2021.

**Eligibility**

Candidates for admission to the M.Phil Programme shall have a Master's degree or a Professional degree declared equivalent to the Master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate or its equivalent grade "B" in the UGC seven point scale or an equivalent degree from a foreign educational institutional accredited by an Assessment and Accreditation Agency. A relaxation of 5% of marks or an equivalent relaxation of grade may be allowed for those belonging to SC/ST/OBC/Differently abled category candidates. Further admission will be made through **an entrance test**.

**Submission of application**

Application forms and prospectus can be downloaded from the university website i.e [www.sjsv.nic.in](http://www.sjsv.nic.in). duly filled up application forms with all required documents as per the prospectus and Bankers Cheque / Demand Draft for Rs. 800/- (Rupees Eight hundred) only in favour of **Comptroller of Finance, SJSV, Shri Vihar, Puri** payable at SBI, SJSVV Branch, Br. Code No. 16102 / any other Nationalized Bank in Orissa should be sent to **the Office of the Chairman, P.G.Council , Shri Vihar , Puri -3** only by Regd. Post / Speed Post on or before 30.11.2020 positively . No application by hand or any other manner for submission is entertained. The last date of application is 30.11.2020. Incomplete & otherwise filled up application will be summarily rejected. The applicants are required to annex a self-addressed envelope affixed with postal stamp at the cost of Regd. Post or Speed Post in order to get the intimation letter. Similarly for index letter a self-addressed envelope with postal stamp for general post be attached. Failing which neither intimation nor index letter will be served.
