

In pursuance of the notification no. 45358/HE, dt. 12.11.2024, Govt. Department of Higher Education, Government of Odisha has notified for implementation of National Educational Policy (NEP) 2020 in all under graduate (UG) courses under Higher Education Institutions (HEIs) starting from the Academic Session 2024-25. It is hereby notified that the said new syllabus is implemented in the UG i.e. Shastri (+3) courses under this University from the Current Academic Session 2024-25. The Courses has been approved by the Academic Council meeting and Syndicate meeting of the Univeristy held on 22.10.2024 & 29.10.2024 respectively prepared by the different Board of Studies under NEP-2020.

The implementation of NEP-2020 in the above courses aims at the following.

1. Introdution of a new, credit-based Undergraduate (UG) curriculum with Four Year Degree with Honours/Research having multiple entry and exit options to facilitate student mobility and flexibility.
2. Incorporation of multidisciplinary courses along with vocational, skill-based and value added courses to enhance employability and industry readiness.
3. Mandatory provision for internship opportunities, enabling students to gain practical exposure and industry experience.
